## RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA

SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Redevelopment Authority of the City of Philadelphia, without consideration, deed conveying conditional fee simple title to 1716 West Arlington street, 1712 Master street, 1901 West Oxford street, 1608 West Stiles street, 1045 West Tioga street, 2455 North 15th street and 1324 North 17th street pursuant to Chapter 16-400 of The Philadelphia Code, under certain terms and conditions.
