WHEREAS, an Ordinance (Bill No. 040569), approved July 1, 2004, was conditional upon certain requirements being complied with within one (1) year from the date of approval;

WHEREAS, an Ordinance (Bill No. 050788), approved November 17, 2005, amended Section 2 of Bill No. 040569 by extending the period for compliance with the requirements stated therein to July 1, 2007; and

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Section 2 of an Ordinance (Bill No. 040569) approved July 1, 2004, as amended by Bill No. 050788 (approved November 17, 2005), is hereby further amended to read as follows:

SECTION 2. This authorization is conditional upon compliance with the following requirements [by July 1, 2007] by July 1, 2010:

SECTION 2. This Ordinance shall not become effective unless the sum of two-hundred dollars (\$200.00), toward costs thereof, is paid into the City Treasury within one-hundred twenty (120) days after this Ordinance becomes law.
