THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Section 9-604 of The Philadelphia Code is hereby amended to read as follows:

§ 9-604. Refuse Collection.

(5) Private Garbage Collection.

(b) No Garbage Collection License shall be issued unless the applicant:

(.2) pays an annual license fee of [fifty (50.00) dollars] *five hundred dollars* (\$500.00) for the Garbage Collection License;

(6) Private Waste Collection.

(b) No Waste Collection License shall be issued unless the applicant:

* * *

(.3) pays an annual license fee of [\$50.00] five hundred dollars (\$500.00) for the Waste Collection License;

(7) Recyclable Material Collection.

(b) No Recyclable Material Collection License shall be issued unless the applicant:

* * *

(.3) pays an annual fee of [\$50.00] *five hundred dollars (\$500.00)* for the Recyclable Material Collection License;
