RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA

SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Redevelopment Authority of the City of Philadelphia, without consideration, deed conveying conditional fee simple title to 3343 North Hancock street, 4615 Hawthorne street, 335 East Lehigh avenue, 3021 North Leithgow street, 2208 North Mascher street, 2661 North Orianna street, 2421 North Palethorp street, 3202 & 3204 Potter street, 921 West Sterner street, 322 East Tioga street, 2126 North 3rd street and 2926 North 3rd street pursuant to Chapter 16-400 of The Philadelphia Code, under certain terms and conditions.
