THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Chapter 14-1800 of The Philadelphia Code is hereby amended to read as follows:

CHAPTER 14-1800. ZONING BOARD OF ADJUSTMENT.

* * *

§ 14-1805. Hearings.

* * *

(2) [Four] *Three* members of the Board shall constitute a quorum for any public hearing required under this Title.

* * *

(3) [The concurring vote of a majority of the Board, present and constituting a quorum at a public hearing, shall be required for action by the Board.] No action shall be taken by the Board unless at least three members of the Board, present at the time of the vote, concur.

SECTION 2. This Ordinance shall become effective immediately.
