**WHEREAS**, There is much confusion with regard to the role of the Redevelopment Authority and the Department of Public Property to accomplish these goals; now therefore, be it,

**RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA,** That the Committee on Housing, Neighborhood Development and the Homeless Hold Public Hearings to Examine the Roles of the Redevelopment Authority and the Department of Public Property in Improving Housing in the City of Philadelphia.
