#### THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Permission is hereby granted to the University of the Sciences in Philadelphia to construct, own and maintain various right-of-way encroachments as follows:

## **Encroachment Description**

A total of six (6) tables, approximately two feet (2') in diameter, to accommodate a total of twelve (12) occupants, are proposed for the south sidewalk of Woodland Avenue. Three (3) tables will be located adjacent to the building and will encroach approximately four feet - six inches (4'-6") onto the south sidewalk of

Woodland Avenue and three (3) tables will be located adjacent to the building and will encroach approximately two feet - six inches (2'-6") onto the south sidewalk of Woodland Avenue leaving approximately six feet - six inches (6'-6") of clear unobstructed footway. No rails will be used.
