THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Section 5 of an Ordinance (Bill No. 110436) approved June 23, 2011, is hereby amended to read as follows:

SECTION 5. The permission granted to Kimmel Center, Inc. to construct, own and maintain the encroachments described in Section 1 shall expire without any further action by the City of Philadelphia if Kimmel Center, Inc. has not entered into an Agreement and satisfied all requirements of the Agreement that are listed in Section 4 of this Ordinance [within one (1) year after this Ordinance becomes law] by August 9, 2013.

SECTION 2. This Ordinance shall not become effective unless the sum of two hundred dollars (\$200.00), toward costs thereof, is paid into the City Treasury within sixty (60) days after the date this Ordinance becomes law.
