## RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA

SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Philadelphia Redevelopment Authority, without consideration, deed conveying conditional fee simple title to 2828 North Darien street, 2034 North Lawrence street, 2039 North Orkney street, 2915 North Orianna street, 2139 North Philip street, 743 West Schiller street and 194 West Stella street pursuant to Chapter 16-400 of The Philadelphia Code and certain terms and condition.

SECTION 2. The Philadelphia Redevelopment Authority is hereby authorized to dispose of the
