THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Chapter 17-104 of The Philadelphia Code is hereby amended to read as follows:

TITLE 17. CONTRACTS AND PROCUREMENT.

* * *

CHAPTER 17-104. Prerequisites to the Execution of City Contracts.

* * *

- (3) Contractor Obligation to Disclose the Number of Women Serving as Board Members and Executive Staff.*
- (a) Bid conditions, requests for proposals, and all other specifications for contracts awarded by the City must require that bidders and all others seeking City contracts must:*
- (i) disclose the current percentage of female executive officers in the company and the current percentage of females on the company's executive and full boards;*
 - (ii) the company's aspirational goals for the inclusion of females in executive positions and on the executive and full boards; and*
 - (iii) the intended efforts by the contractor to achieve the aspirational goals.*
