# ARTICLE VIII PROVISIONS FOR GENERAL APPLICATION

### CHAPTER 1 FISCAL AND BUDGETARY MATTERS

#### § 8-108. Appeals from Interest Arbitration Awards

No appeal by the City of Philadelphia of an Interest Arbitration Award or any part thereof of a board of arbitration established pursuant to the provisions of the Act of June 24, 1968 (P.L. 237, No. 111), referred to as the Policemen and Firemen Collective Bargaining Act, or the Act of July 23, 1970 (P.L. 563, No. 195), referred to as the Public Employee Relations Act, may be pursued unless such appeal is expressly authorized by the Administrative Board and approved by a two-thirds vote of the Council at each level of appeal.
