## THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Pursuant to Section 14-106 of The Philadelphia Code, the Philadelphia Zoning Maps are hereby amended by changing the zoning designations of certain areas of land within an area bounded by Springfield Avenue (extended), 58th Street, Lindbergh Boulevard, 60th Street, Elmwood Avenue, 77th Street (extended), and Cobbs Creek from the existing zoning designations indicated on Maps "A1" "A2" "A3" "A4" and "A5" set forth below to the zoning designations indicated on Maps "B1" "B2" "B3" "B4" and "B5" set forth below.
