SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Philadelphia Redevelopment Authority, without consideration, deed conveying conditional fee simple title to 5117 Lena street, 4537 & 4539 Pulaski street and 3306 North 20th street pursuant to Chapter 16-400 of The Philadelphia Code under certain terms and conditions.
