*THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:*

SECTION 1. Title 4 of The Philadelphia Code is hereby amended to read as follows:

*SECTION PM-607.0 SOLAR PANEL REGISTRATION*

*PM-607.1. No person shall maintain or install a solar panel on the roof of any property without registering such installation with the Fire Department, in such manner as may be prescribed by the Fire Department.*

**Section PM-706**  
**SOLAR PANEL REGISTRATION**
