THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Title 14 of The Philadelphia Code is hereby amended to read as follows:

TITLE 14. ZONING AND PLANNING.

CHAPTER 14-500. OVERLAY ZONING DISTRICTS.

§14-503. /NCA, Neighborhood Commercial Area Overlay.

* * *

(11) Center City East.

(a) District Boundaries.

The requirements of this Center City East /NCA Overlay district apply to all properties in the area bounded by the Delaware River, Spring Garden Street, Broad Street and Spruce Street.

(b) Use Regulations.

(.1) Personal Credit Establishment uses and the expansion or extension of such uses shall be prohibited.

SECTION 2. This Ordinance shall become effective immediately.
