SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Philadelphia Redevelopment Authority, without consideration, deed conveying conditional fee simple title to 2210, 2212, 2216 & 2228 Ridge Avenue, 2011-23 Sharswood Street, 2424 Stewart Street, 1203 North Taylor Street, 2431 West Thompson Street, 2014, 2039, 2400, 2418, 2434 & 2540 Turner Street, 1337, 1341 & 1400 North 21st Street, 1319 & 1333 North 23rd Street, 1301 North 24th Street and 1331, 1524 & 1535 North 27th Street pursuant to Chapter 16-400 of The Philadelphia Code and certain terms and conditions.
