THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Section 9-213 of The Philadelphia Code is hereby amended to read as follows:

CHAPTER 9-200. COMMERCIAL ACTIVITIES ON STREETS.

§ 9-213. Farmers' Markets.

(7) Permissible Locations. Farmers' Markets at the following locations shall be permitted:

* * *

(tt) The sidewalks and curb lanes of both sides of the 3500 block of Ryan Avenue from Frankford Avenue and extending 156 feet northwest of the northwest line of Frankford Avenue, provided the hours of operation shall be [Sundays] *Thursdays* from [9:30AM to 3:30 PM] *4PM to 9PM*, from April 1st through October 31st.
