SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Philadelphia Redevelopment Authority, without consideration, deed conveying conditional fee simple title to 425 East Clearfield street, 3456 Dillman street, 2407, 2530 & 3030 North Leithgow street, 2547 North Mutter street and 2606 North Orianna street, pursuant to Chapter 16-400 of The Philadelphia Code under certain terms and conditions.

SECTION 2. The Philadelphia Redevelopment Authority is hereby authorized to dispose of the
