The Commissioner of Public Property is hereby authorized to execute and deliver to the Philadelphia Redevelopment Authority, without consideration, deeds conveying conditional fee simple title to 2862 Amber street, 2863 Amber street, 2261, 2263 & 2265 East William street and pursuant to Chapter 16-400 of The Philadelphia Code under certain terms and conditions.
