RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA

SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Philadelphia Redevelopment Authority, without consideration, deed conveying conditional fee simple title to 2403 & 2405 North Orianna street, 2606 North Orianna street, 2315 & 2446 North Orkney street, 1915 North Philip street, 2912 Rutledge street, 2234 North 2nd street and 2124 North 4th street pursuant to Chapter 16-400 of The Philadelphia Code under certain terms and conditions.

SECTION 2. The Philadelphia Redevelopment Authority is hereby authorized to dispose of the
