*THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:*

SECTION 1. Section 9-213 of The Philadelphia Code is hereby amended to read as follows:

§9-213. Farmers' Markets.

(7) Permissible Locations:

*(ccc) the sidewalk, adjoining curb lane, and parking lot located at 1290 Southampton Road (notwithstanding any contrary provision in Title 14).*
