## THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Section 9-204 of The Philadelphia Code is hereby amended to read as follows:

§9-204. Sidewalk Vendors in Center City.

(a) The following vendor locations are hereby designated as locations from which vending shall
