RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA

SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Philadelphia Redevelopment Authority, without consideration, deed conveying conditional fee simple title to 814 & 818 West Norris street, 3010, 3012, 3013, 3014, 3038 & 3040 West York street, 1914 & 1916 North 7th street, 2302, 2325, 2333 & 2341 North 30th street and 2327, 2338, 2340, 2342, 2346 & 2348 North 31st street pursuant to Chapter 16-400 of The Philadelphia Code under certain terms and conditions.

SECTION 2. The Philadelphia Redevelopment Authority is hereby authorized to dispose of the

aforementioned properties for rehabilitation and/or improvements under certain terms and conditions pursuant to Chapter 16-400 of The Philadelphia Code.
