RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA

SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Philadelphia Redevelopment Authority, without consideration, deeds conveying conditional fee simple title to 2118 East Auburn Street, 2317 & 2831 Coral Street, 1922, 1924 & 1941 East Harold Street, 1834 East Huntingdon Street, 2329 South Marshall Street, 623 Mercy Street, 2035 Orleans Street and 1823 North 2nd Street and pursuant to Chapter 16-400 of The Philadelphia Code under certain terms and conditions.

SECTION 2. The Philadelphia Redevelopment Authority is hereby authorized to dispose of the
