THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Section 1 of Bill No. 150162-A (approved June 18, 2015), as amended by Bill No. 150611 (approved October 2015), is hereby further amended to read as follows (matter added by amendment is in *italics*; matter deleted by amendment is in ~~strike through~~):

SECTION 1. A Capital Program for the six Fiscal Years 2016 to 2021, inclusive, totaling eight billion nine hundred ~~eighty-nine~~ *ninety-two* million ~~eight~~ *three* hundred forty-seven thousand ~~(8,989,847,000)~~ *(8,992,347,000)* dollars in estimated costs, is hereby adopted as set forth in the attached Exhibit A.
