WHEREAS, If a neighborhood school is set to be closed, the community should be notified before the final decision to close a school has been made, and have the opportunity to be involved in the process of deciding the final outcome of the school; now, therefore, be it

RESOLVED, THAT THE CITY COUNCIL COMMITTEE ON EDUCATION, Hold hearings on the status of public schools in Philadelphia, the programs that exist and what we can do to insure that every student receives a quality education and support services necessary for positive childhood outcomes.
