THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Section 1 of Bill No. 150162 (approved June 18, 2015), as amended, is hereby further amended to read as follows (matter added by amendment is in *italics*; matter deleted by amendment is in ~~strike through~~):

SECTION 1. A Capital Program for the six Fiscal Years 2016 to 2021, inclusive, totaling eight billion nine hundred ninety-two five million three hundred forty-seven thousand ~~(8,992,347,000)~~ *(8,995,347,000)* dollars in estimated costs, is hereby adopted as set forth in the attached Exhibit A.
