THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Pursuant to Section 11-402 of The Philadelphia Code, the Board of Surveyors of the Department of Streets is hereby authorized to revise the lines and grades on a portion of City Plan Nos. 305 and 306 by:

a) Placing on the City Plan Delaware Avenue from Orthodox Street to Buckius Street.

- b) Widening Buckius Street from Delaware Avenue to Richmond Street by relocating the southwesterly houseline of said Buckius Street a variable distance southwestwardly.
- c) Placing on the City Plan a right-of-way for drainage purposes extending from a point on the northeasterly side of Buckius Street, at its crossing by the right-of-way of the Philadelphia Belt Line Railroad, southeastwardly to the Bulkhead Line of the Delaware River.
