SECTION 2. The following truck route is hereby established:

TRUCK ROUTE

Lewis Street between Richmond Street and Delaware Avenue.

SECTION 3. This Ordinance will expire upon the determination by the Department of Streets that construction has been completed on Delaware Avenue between Allegheny Avenue and Buckius Street.
