RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA

SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Philadelphia Redevelopment Authority, without consideration, deed conveying conditional fee simple title to 1953 North Croskey Street, 2129 North Dover Street, 2501 West Seltzer Street and 2632 North 30th Street pursuant to Chapter 16-400 of The Philadelphia Code and certain terms and condition.

SECTION 2. The Redevelopment Authority is hereby authorized to dispose of the aforementioned
