Title: Amending various provisions of The Philadelphia Code, including Chapter 6-300 (entitled "Food"), Title 9 (entitled "Regulation of Businesses, Trades and Professions"), Chapter 10-700 (entitled "Refuse and Littering"), Chapter 11-500 (entitled "Paving"), and Chapter 19-600 (entitled "Amusement Tax"), to revise various provisions relating to fees; including for licenses and permits for food establishments, newspaper boxes, public parking lots, conducting amusements, handbill distribution and sidewalk paving; and to authorize revisions of various fees by regulation; all under certain terms and conditions.
