WHEREAS, It is necessary for the citizens of our global community to develop green jobs and to build an innovative and equitable green economy to combat the aforementioned global challenges; and

WHEREAS, Expanding environmental education and climate literacy is vital to enhance awareness about the environment, inform decision-making, and protect future generations, and

WHEREAS, Now more than ever, it is critical that we continue to act locally and cooperate internationally to defend the environmental progress that has been achieved; and

WHEREAS, Earth Day is an annual reminder of the constant need for environmental activism, stewardship commitments, and sustainability efforts; and

WHEREAS, Energy efficient choices can save families about a third on their home energy bills with similar savings of greenhouse gases without sacrificing style or comfort; and
