WHEREAS, Medical research efforts focused on lupus and the discovery and development of safer, more effective treatments for lupus patients are under-funded in comparison with diseases of similar magnitude and severity; and

WHEREAS, People with lupus will face a lifetime of living with the unpredictable and life-changing health effects of this disease; and

WHEREAS, There is a deep, unmet need to educate and support individuals and families affected by lupus; and
