SECTION 1. The Philadelphia Land Bank is hereby authorized to enter into a lease agreement with HACE, as tenant, for use by HACE of those properties identified in attached Exhibit "A" pursuant to Chapter 16-700 of The Philadelphia Code and Act 153 of 2012, 68 Pa. C.S.A. § 2101, et seq.
