WHEREAS, Sandmeyer Steel was founded by the late Paul C. Sandmeyer in 1952, with a vision of producing stainless steel, nickel alloy and titanium products for use in American manufacturing; and

In his 28 years at this position, he continually worked to improve the company, increase profits, and provide a great and safe place to work for his employees; and

WHEREAS, In 1997, Ronald Sandmeyer, Sr. stepped down from his role as President & CEO, and passed it onto his son Ronald Sandmeyer, Jr., while maintaining his role as Chairman of the Board; and

WHERAS, Many of Sandmeyer, Sr's qualities as a leader are embodied in the Vision of the Sandmeyer Steel Company, including "Creating a great and safe place to work for members of the Sandmeyer Team", "making significant contributions to the communities in which we work and live" and "making a positive impact on the quality of life of members of the Sandmeyer Team and their families."
