WHEREAS, For his dedicated time to the University he was also awarded the Mount Nittany Society 2008 Lifetime Award which represents the pinnacle of philanthropy and is awarded to individuals with an exceptional cumulative giving to the University; and

WHEREAS, Michael is also heavily involved with Irish events and societies, he was named the Mayo Association of Philadelphia's Outstanding Member in 2007, awarded the AOH LAOH Division 87 Port Richmond Slainte Award, named the Philadelphia Fraternal Order of Police's Emerald Society Man of the Year in 2010, named the Philadelphia Irish Immigration and Pastoral Center's Philly Irish Person of the Year in 2007, and named to the Delaware Valley's Irish Hall of Fame in 2007; and
