RESOLVED, BY THE COUNCIL OF THE CITY OF PHILADELPHIA, as follows:

SECTION 1. The Commissioner of Public Property is hereby authorized to execute and deliver to the Philadelphia Redevelopment Authority, without consideration, deeds conveying conditional fee simple title to 1618 North Bodine Street, 1620 North Bodine Street and 1622-42 North Bodine Street, pursuant to Chapter 16-400 of The Philadelphia Code as it was in effect on December 31, 2019.

SECTION 2. The Philadelphia Redevelopment Authority is hereby authorized to dispose of the aforementioned
