WHEREAS, The shift from commercial waste to residential waste resulting from the work from home mandates has placed more of the burden on the Sanitation department; and

WHEREAS, Sanitation workers, overwhelmingly from the communities of color, are disproportionately impacted by the COVID-19 pandemic; and

WHEREAS, COVID-19 has created a series of additional challenges for sanitation workers as they manage increased loads and demands while living in the neighborhoods most impacted by the pandemic; and

WHEREAS, Sanitation workers are essential to a functioning city, we propose investigating best practices, current conditions, and employment trends to make sure a non-negotiable service can continue to be faithfully provided; now, therefore, be it
