WHEREAS, New committee members for 2020 include Mary Marques, Jael Conde and Juan Giarrizzo; and

WHEREAS, The open-fair style event was a smashing success, with over 31 Hispanic authors participating; and

WHEREAS, Attendees were treated to meet and greets with local authors, book and poetry readings, food tastings, and musical performances; and

WHEREAS, This year's event, in accordance with public health guidelines, will be held virtually from October 15-17; and
