Amending Bill No. 200286 (Approved June 26, 2020), entitled "An Ordinance to adopt a Fiscal 2021 Capital Budget."

*THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:*

SECTION 1. Section 1 of Bill No. 200286 (Approved June 26, 2020) is amended as follows: (deletions in ~~Strikethrough~~; additions in **Bold**):

SECTION 1. A Capital Budget for the Fiscal Year 2021, totaling three billion, ~~one~~ **two** hundred ~~fifty~~ **two** ~~ninety~~ **six** million, and three hundred and twenty five thousand dollars (\$3,152,325,000 ~~3,296,325,000~~), is hereby adopted as set forth in the attached Exhibit A.
