WHEREAS, Based on demographic studies commissioned by the Boys and Girls Club of America, the neighborhood where Rose Playground is located is well situated to serve a significant number of children and families that are not currently being serviced by the organization; and

WHEREAS, The programs and services offered by the Boys and Girls Club of Philadelphia have been proven to achieve incredible outcomes by providing a safe and supportive environment for our city's youth. As such, Philadelphia City Council should examine the organization's potential for expansion; now, therefore, be it
