She has been active with those bodies for a number of years, in service of her passion for airports' potential to connect communities with the world, grow local economies, and foster a more diverse and inclusive workforce; and

WHEREAS, In recognition of her leadership within the industry, Ms. Cameron has been elected to serve as chair of the U.S. Policy Council for Airports Council International - North America in 2021. As chair of the U.S Policy Council, Cameron is in charge of building consensus among her peers and vocalizing priorities to the White House, Capitol Hill and the aviation industry; and
