THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. Chapter 6-700 of The Philadelphia Code is hereby amended to read as follows:

## CHAPTER 6-700. MAINTENANCE AND OPERATION OF DISTRICT HEALTH CENTERS

\* \* \*

§ 6-710. Availability of Feminine Hygiene Products.

- (1) Definition. For purposes of this Section, the term "feminine hygiene products" shall mean the tampons and sanitary napkins for use in connection with the menstrual cycle.
- (2) Availability of feminine hygiene products. District Health Centers shall provide feminine hygiene products to be used at the facility, either by use of a dispenser or to individuals upon their request.

SECTION 2. Chapter 15-500 of The Philadelphia Code is hereby amended to read as follows:

### CHAPTER 15-500. LIBRARIES

\* \* \*

§ 15-502. Availability of Feminine Hygiene Products.

- (1) Definition. For purposes of this Section, the term "feminine hygiene products" shall mean the tampons and sanitary napkins for use in connection with the menstrual cycle.
- (2) Availability of feminine hygiene products. Libraries shall provide feminine hygiene products to be used at the facility, either by use of a dispenser or to individuals upon their request.

SECTION 3. Chapter 15-700 of The Philadelphia Code is hereby amended to read as follows:

#### CHAPTER 15-700. RECREATION CENTERS

\* \* \*

§ 15-705. Availability of Feminine Hygiene Products.

- (1) Definition. For purposes of this Section, the term "feminine hygiene products" shall mean the tampons and sanitary napkins for use in connection with the menstrual cycle.
- (2) Availability of feminine hygiene products. Staffed recreation centers shall provide feminine hygiene products to be used at the facility, either by use of a dispenser or to individuals upon their request.
