Authorizing the Commissioner of Public Property, on behalf of the City of Philadelphia, to convey to the Commonwealth of Pennsylvania, all or a portion of a parcel or parcels of land in and about the area bounded by Front Street, East Allen Street, Canal Street and Laurel Street, under certain terms and conditions.

THE COUNCIL OF THE CITY OF PHILADELPHIA HEREBY ORDAINS:

SECTION 1. The Commissioner of Public Property, on behalf of the City of Philadelphia, is hereby authorized to convey to the Commonwealth of Pennsylvania some or all of the parcels of land located in and about the area bounded by Front Street, East Allen Street, Canal Street and Laurel Street, as more particularly identified in Exhibit "A", under certain terms and conditions.

SECTION 2. The City Solicitor is hereby authorized to review and to approve, prior to execution, all instruments and documents necessary to effectuate this Ordinance, which instruments and documents shall

contain such terms and conditions as the City Solicitor shall deem necessary and proper to protect the interests of the City.
