SECTION 2. The Philadelphia Redevelopment Authority is hereby authorized to transfer to the Philadelphia Land Bank fee simple title to 3217, 3241, 3248, 3253, and 3257 N. 15th Street, 3333, 3340, 3342, and 3346 N. 16th Street, 3305, 3314, 3316, 3320, 3327, 3331, 3342, 3344, 3346, 3412 and 3414 N. 17th Street pursuant
