WHEREAS, South by South by Southwest ("SXSW") is a conference and festival held in Austin, Texas that offers the unique convergence of independent films, original music and emerging technologies while fostering creative and personal growth; and

WHEREAS, SXSW is a launching pad for new creative content, media presentations, music showcases and film screenings, and also provides conference panel discussions which present a forum for learning, business activity and global networking opportunities; and
